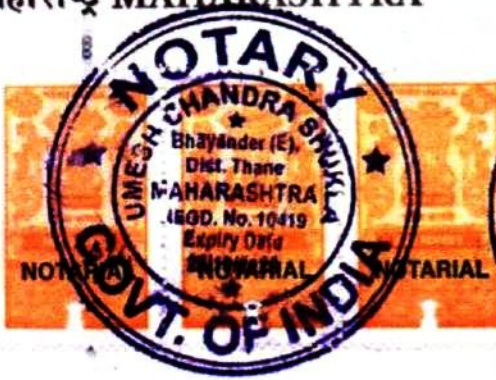

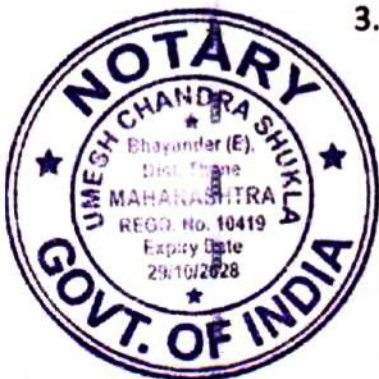

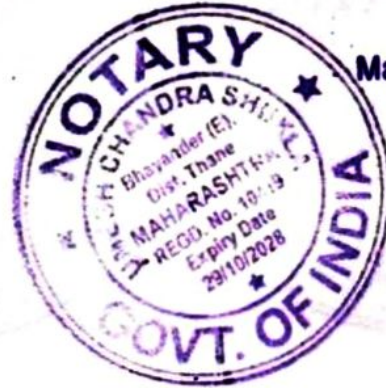

7. That the Principal and Correspondent/ Manager of the school have individually gone through the provisions contained in the affiliation and examination bye-laws and circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time and the law of the land.








13. That the school will not coerce any student/parents to buy books/ stationery/ uniform from any particular shop.
